THREE YEAR EXPERIENCE STUDY

B. Heinrichs, J. Davidson and J. Griffin represented the firm of Foster and Foster. They reviewed with the Board the results of the experience study of the actuarial assumptions and methods used for actuarial valuation purposes over the period of three years from October 1, 2017 thru September 30, 2020. A question-and-answer session followed the presentation. The report was accepted by a motion by T. Gabriel a second from T. Roell and a unanimous vote.

The Board Chairman created a Committee to work with the Actuaries and the Consultants on a review of assumptions presently being used. T. Gabriel, N. Enriquez, R. Suarez and S. MacDonald were appointed to the Committee.

INVESTMENT /ISSUES AND PERFORMANCE REVIEW QE 12/31/2020

MEKETA – Represented by G. Bikkesbakker, A. Lally and S. Bowen

The Consultants reviewed with the Board specific events that transpired during 2020 and their effect on the market. They reviewed the performance for quarter ending December 31, 2020, which showed a fiscal year-to-date return of 8.9% and a total fund asset value of \$1,735,941,814.

Asset Study Comparison 2021 Projections vs 2019 Projections

The Study showed that return expectations, for nearly all assets, decreased because (1) lower yields in fixed income result in lower forward-looking return expectations and (2) higher prices for public equities along with lower expected growth/earnings result in lower forward-looking return expectations. The Study reflected that risk expectations remained the same for many classes. Expected returns were shown to be -1.3% and expected standard deviation were shown to be +0.4%.

- Keep the long term in mind
- Recognize the goal is a long-term return over actuarial target
- Trust the long-term asset allocation
- Don't let the tail wag the dog
- Rebalance!
- Increase risk assets when expectations are higher
